

# Accelerating transport decarbonisation is central to delivering against the UK's legally binding commitment to net zero


• Transport remains the largest emitting sector of the UK economy, accounting for 26% of domestic

greenhouse gas (GHG) emissions in 2021.

#### UK domestic greenhouse gas (GHG) emissions by transport mode, 1990 - 2021








# The UK Government has set out an ambitious, cross-modal approach to reducing transport emissions...

These publications detail the measures needed to decarbonise the transport sector in line with its contributions to our economy-wide commitments, and net zero by 2050.

#### Key planks of our approach

Accelerate the transition to zero emission road vehicles, with no new non-zero emission sales after 2040 – starting with cars and vans.



Ensure people have sustainable travel choices- whether that's by zero emission car, public transport or walking or cycling.



Increase the use of low carbon fuels in hard to decarbonise modes such as aviation and maritime, alongside continued R&D into zero emission tech options.







# Delivering decarbonisation through places

- In the Transport Decarbonisation Plan, we set out the importance of place-based solutions to emissions reduction.
- Of all UK emissions, 82% are within the scope of influence for Local Authorities.
- By 2050, we want every place in the UK to have its own net zero transport network- serving the unique needs of its communities.
- This is not only through the transition to zero emission cars and vans, and greener vans and lorries...
- but also enabling choice through making journeys more walkable and cyclable and helping people shift to public transport.






# Unlocking the benefits of innovation and technology

- Supporting the development of innovative technologies is a vital part of ensuring the UK is best placed to meet its net zero commitments.
- We want to help businesses and Local Authorities work together to unlock the benefits of technology and innovation in transport.
- We are working with Innovate UK on the Transport Decarbonisation Demonstrators.
- This includes in so-called 'hard to decarbonise areas'- which is why we are committing half of the funding available to tackle rural challenges.

# **Competition aim**

The aim of this competition is to support innovative R&D solutions that can demonstrate the potential to:

- reduce transport carbon emissions in local areas
- facilitate collaboration between Local Authorities (LA) and businesses



# Competition scope

#### Your proposal must:

- detail the potential to reduce carbon and other harmful emissions from the existing local transport network
- demonstrate the consideration of a place-based approach and how the solution proposed best meets the needs and attributes of the selected demonstration area
- identify the Local Authority capacity to support and be involved with the project
- illustrate how the innovation activity fits in with, and will support local strategies or plans, such as a Local Authorities' Local Transport Plan (LTP) or Net Zero strategy
- provide evidence of Local Authority senior leadership or senior level support for the proposed activity
- detail how the solution will be demonstrated



## Competition scope

On completion of the funded project, you must submit a report

#### The report must:

- quantify how the project supported the overall reduction in transport carbon emissions for the selected region or area
- identify any positive or negative outcomes or impacts as a result of the trial outside of decarbonisation
- describe the impact of adopting your local or place-based solution
- indicate whether the demonstrated solution could be replicated elsewhere and if so, where
- describe the future of the proposal in and beyond the local demonstration



# **Eligibility**

#### Your project must:

- have a grant funding request of between £100,000 to £500,000
- start on 1 June 2024
- end by 31 March 2025
- last between 6 to 10 months
- carry out all of its project work in the UK
- intend to exploit the results from or in the UK
- involve a minimum of two collaborative grant claiming partners
- can be a previously submitted application
- must be a feasibility studies or industrial research project, as defined in the <u>guidance on</u> <u>categories of research</u>.



# Out of scope

We are not funding projects that are:

- looking solely at data gathering
- focusing on large scale infrastructure and not considering a place-based approach
- maritime projects including shipping and ports
- based on developing airport infrastructure or urban airports
- solely focused on on-vehicle developments
- using vehicles which are not zero-emission
- using vehicles are that over 7.5 tonne that do not support passenger transport, local authority operations or emergency services



# **Funding**

- Up to £2 million has been allocated to fund innovation projects in this competition.
- Of the £2 million allocated, up to £1 million will be reserved for rural transport solutions, including national parks and geographies with similar rural-associated transport challenges.
- Grant funding request of between £100,000 to £500,000
- Funding will be in the form of a grant.



# Portfolio approach

We want to fund a variety of projects across different technologies, geographies and types of place. We call this a <u>portfolio approach</u>.

There is a radio button (unscored) within the application questions where applicants will be asked whether they would define their project as a primarily rural solution



#### Consortium

#### **Lead organisation**

To lead a project your organisation must be a UK registered business of any size.

#### **Project team**

To be an eligible collaboration, the lead must collaborate with a minimum of at least one grant claiming Local Authority (LA) as part of their project team.

In addition, you can also invite other collaborative partners. To collaborate with the lead, your organisation must be one of the following UK registered:

- business of any size
- academic institution
- charity
- not for profit
- public sector organisation
- research and technology organisation (RTO)

Further information on 'local authority' classification can be found in the competition guidance.



# **Research Participation**

The research organisations undertaking non-economic activity as part of the project can share up to 50% of the total eligible project costs. If your consortium contains more than one research organisation undertaking non-economic activity, this maximum is shared between them.

Of that 50% you could get funding for your eligible project costs of up to:

- 80% of full economic costs (FEC) if you are a Je-S registered institution such as an academic
- 100% of your project costs if you are an RTO, charity, not for profit organisation, public sector organisation or research organisation



# Non-funded partners and subcontrators

#### Non-funded partners

Your project can include partners that do not receive any of this competition's funding, for example non-UK businesses. Their costs will count towards the total project costs.

#### **Subcontractors:**

- permitted in this competition
- can be from anywhere in the UK
- must be selected through your usual procurement processes
- the use of any overseas subcontractor must be justified in your application, explaining why you could not use suppliers from the UK



# **Number of applications**

#### **Businesses**

A business can only lead on one application but can be included as a collaborator in a further 2 applications.

#### **Local Authorities**

Local Authorities, or similar organisations as described, can only collaborate on two separate applications.

#### Other organisations

Academic institutions, research and technology organisations (RTO), charities, not for profits or other public sector organisations can be included as a collaborator in any number of applications.



# **Funding**

#### **Funding rules**

The level of funding awarded will depend upon the type of organisation and the type of research being undertaken in the project

Funding is calculated by project participant

IFS will advise the maximum grant % you can request based upon your answers to:

- type and size of organisation
- research category defined by the lead applicant in the Application Details section of the application



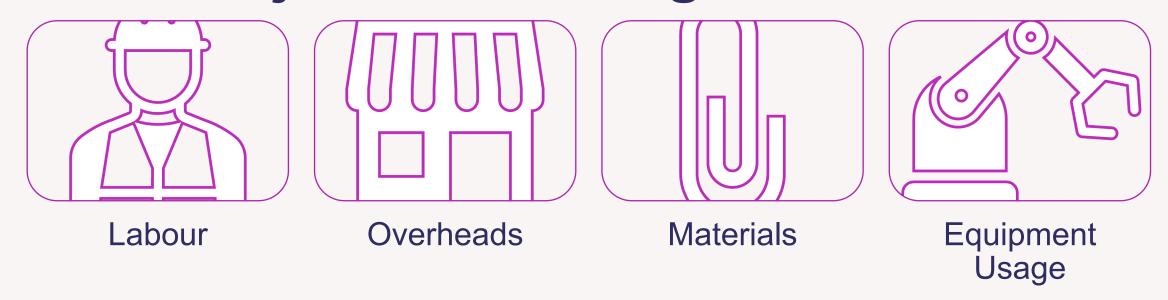


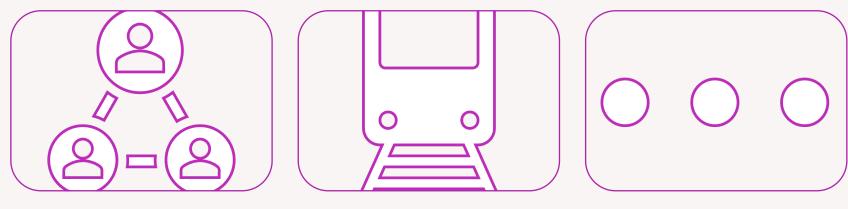
#### **Eligibility Criteria: Funding Levels**

| Feasibility studies and industrial research  | Research organisations |
|--|------------------------|
| 70% if you are a micro or small organisation | 100% funding           |
| 60% if you are a medium-sized organisation   |                        |
| 50% if you are a large organisation          |                        |

#### **Conditions of Award**

Under the Subsidy Control Regime, we will conduct a financial review and seek assurances on your organisation, leadership team, and persons of significant control.

#### Certify you are eligible

When submitting an application, you must certify that you are eligible for funding. If you are unsure, please take independent legal advice before applying. You must pass our financial review and assurances before being offered a conditional award.



#### Other Innovate UK projects

If you have an outstanding final claim or Independent Accountant Report (IAR) on a live Innovate UK project, you will not be eligible to apply to this competition, as a lead or a partner organisation.

We will not award you any further funding if you:

- applied to a previous competition as the lead or sole company and were awarded funding by Innovate UK, but did not make a substantial effort to exploit that award
- applied to a previous competition as the lead or sole company and failed to comply with grant terms and conditions.



# Conditional offer of awarding

If you receive a notification saying you have been successful at the assessment stage, you will have a further 8 steps to complete in Project Setup.

#### These are:

- Project details
- Project team
- Documents
- Monitoring Officer allocation
- Bank details
- Finance checks
- Spend profile
- Grant Offer Letter

Work can only commence on the project once you have signed and returned the Grant Offer Letter.



# **Project Impact questions**

- Each organisation in your application will complete the Project Impact questions within the 'Supporting information' section
- The Project Impact questions ask for data about your business and innovation and its contribution to the UK economy, society, and the environment
- Visit the <u>Project Impact guidance</u> page for more information, the types of questions you will be asked and how to get further support
- By providing this data, you are enabling us to better understand the impact of our support. It will help us identify success stories and provide evidence to government and the public of the value of supporting innovative businesses
